

OIA: 1327797 and 1328172 – requests for information about the University Advisory Group (UAG)

Thank you for your email of 30 April 2024 to the Ministry of Education (the Ministry) requesting the following information:

Are you able to provide all documentation and advice given by the Ministry of Education to Tertiary Education Minister Penny Simmonds relating to the establishment of the University Advisory Group?

We also acknowledge receipt of your email to the Minister for Tertiary Education of the same date, which has been transferred to the Ministry for response, requesting:

All documents and advice received regarding establishing the group, creating its terms of reference, and appointment of group members.

Your requests have been considered under the Official Information Act 1982 (the Act).

The University Advisory Group has been established to provide the Government with advice on New Zealand's university system. The Group will consider challenges and opportunities for improvement in the university sector, including the role of the Performance Based Research Fund; ways to best achieve equity for all learners; and the role of international education. The Group will provide an initial report to the Ministry in August 2024, with a final report in February 2025.

We have identified 11 documents, or extracts of documents, within scope of your request. I am releasing five of these documents to you in part and refusing the remaining six documents under section 18(d) of the Act, as the information is, or will soon be, publicly available on the Ministry's website. Some information has, or will be withheld, for the information under the following sections of the Act:

section 9(2)(a) of the Act, to protect the privacy of natural persons;



- section 9(2)(f)(iv) of the Act, to protect the confidentiality of advice tendered by Ministers of the Crown and officials; and
- section 9(2)(g)(i) of the Act, to maintain the effective conduct of public affairs through the free and frank expression of opinions by, between or to Ministers of the Crown and officials.

As required under section 9(1) of the Act, I have considered the public interest in releasing the information withheld. I do not consider the public interest considerations favouring the release of this information are sufficient to outweigh the need to protect the privacy of the individuals concerned.

These documents are individually detailed, together with my decision as to their release, in **Appendix A: Document Table** below.
