

# **Geraldine Primary School (2107)**

## **Proposed Enrolment Scheme**

**(Updated to Education and Training Act 2020)**

### **Home Zone**

**All students who live within the home zone described below shall be eligible to enrol at the school.**

Note that eligibility to enrol is based on the below written description of the home zone. Any associated maps are a visual representation of this description.

**Addresses on both sides of boundary roads are considered in-zone unless specified otherwise.**

Starting from the meeting of Sheep Dip Road and Wooding Road:

- South east along Wooding Road to Painton Road
- South west along Painton Road to Fairfield Road
- South east along Fairfield Road to McKeown Road
- North east along McKeown Road to Sercombe Road
- East along Sercombe Road to Woodbury Road
- South east and then South along Woodbury Road to Main North Road (SH79)
- North east along Main North Road (SH79) to Geraldine-Arundel Road
- North west then North east along Geraldine-Arundel Road to Arundel Rangitata Road
- South east along Arundel Rangitata Road to Taylor Street North
- North east along Taylor Street North to Cox Street
- South east along Cox Street to Orari-Rangitata Highway (SH1)
- North east along Orari-Rangitata Highway (SH1) to Rangitata River
- South east along the west bank of the Rangitata River to a point in line with Rangitata Hutts Road
- South west across country to Rangitata Hutts Road
- South west and North west then South west along Rangitata Hutts Road to Orton Rangitata Mouth Road
- North west along Orton Rangitata Mouth Road to Badham Road
- South west along Badham Road to Farm Road
- South west along Farm Road to Canal Road
- North west along Canal Road to Factory Road
- South west along Factory Road to the Orari River
- North west along the Orari River to Orari-Rangitata Highway (SH1)
- South west along Orari-Rangitata Highway (SH1) to Temuka-Orari Highway (SH1)
- South west along Temuka-Orari Highway (SH1) to Hawke Road
- West along Hawke Road to Payne Road
- South west across country to the intersection between Waihi River and Beeby Road
- South west along Beeby Road to Wilks Road
- South west along Wilks Road to Winchester Hanging Rock Road
- South east along Winchester Hanging Rock Road to Goodwin Road
- West along Goodwin Road to Seven Sisters Road
- South west along Seven Sisters Road to Rangitira Valley Road
- West along Rangitira Valley Road to Galbraith Road
- North west along Galbraith Road to Saddle Road
- West along Saddle Road to Limestone Road

- North west along Limestone Road to Stevenson Road
- West along Stevenson Road to McBeth Road
- North west along McBeth Road to Winchester Hanging Rock Road
- North along Winchester Hanging Rock Road to Rapuwai Road
- West along Rapuwai Road to Wigley Road
- South west along Wigley Road to Ley Road
- South west along Ley Road to the terminus
- West across country to the Opuha River
- North west along the eastern bank of the Opuha River to Geraldine-Fairlie Highway (SH79)
- North across the country to the western terminus of Te Moana Road
- North east along Te Moana Road to Sheep Dip Road
  - Including all Te Moana Road addresses
  - Including all addresses on Leishman Road and Clayton Pack Track
- North east along Sheep Dip Road to Wooding Road
  - Including all addresses on Chapman Road and Four Peaks Road

Each year, applications for enrolment in the following year from in-zone students will be sought by a date that will be published by public notice in a medium appropriate to the area served by the school. This will enable the board to assess the number of places that can be made available to students who live outside the home zone.

## Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

## Out of Zone Enrolments

Applications for enrolments will be processed in the [following order of priority](#):

1. **First priority** is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.
2. **Second priority** must be given to any applicant who is the sibling of a current student of the school.
3. **Third priority** must be given to any student who is the sibling of a former student of the school.
4. **Fourth priority** must be given to any applicant who is the child of a former student of the school.
5. **Fifth priority** must be given to any applicant who is a child of an employee of the school's board or a child of a member of the school's board.
6. **Sixth priority** must be given to all other applicants.

Before the application deadline associated with each pre-enrolment period, a Board must, by public notice in a medium appropriate to the area served by the school:

- confirm the already advertised dates for the receipt of applications and for the holding of the ballot.
- state the likely number of out of zone places that remain available.

If there are more applicants in any priority group than there are places available, selection within the priority group will be by ballot conducted in accordance with [instructions by the Secretary](#), under [Schedule 20, Clause 3 \(1\)](#) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

**Applicants may be required to give proof of In Zone address, or proof to support their application if seeking enrolment under the Out of Zone priorities.**

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.
