 This report seeks your decisions on key issues for the ECE reform Cabinet paper - Paper 2: Response to the Early Childhood Education Regulatory Sector Review. Your decisions on these issues will be incorporated into the Cabinet paper ahead of Ministerial consultation.

## Key facts, issues and questions

- Paper 2: Response to the Early Childhood Education Regulatory Sector Review seeks
  policy decisions on the response to the Ministry for Regulation's ECE regulatory sector
  review. This Cabinet paper is due to be considered at EXP Cabinet Committee on 25 March
  (see Annex 1).
- We have previously provided you with a draft of this ECE reform Cabinet paper and committed to providing further advice on key issues that need to be resolved before the Cabinet paper can be finalised. Advice on these key issues is provided in this report.
- Your decisions on these key issues will be incorporated into a revised Cabinet paper, in time for you to undertake Ministerial consultation from 12 March. Alongside the Cabinet paper, we have also provided the draft Regulatory Impact Statement in Annex 2. Feedback from agencies will be incorporated following departmental consultation ending on 13 March.

## Alignment with Government priorities

1. This report aligns with Government priorities to improve the quality of regulation, reduce regulatory burden and costs to business, and deliver better public services.

## **Background**

- 2. This report follows previous advice that provided *Paper 2: Response to the Early Childhood Education Regulatory Sector Review* [METIS 134359 refers]. There were key issues in that initial draft Cabinet paper that we needed to undertake further work on. This report provides you with advice and seeks your decisions on these issues, including:
  - 2.1. 9(2)(f)(iv)
  - 2.2. Children's Act interface.
- 3. 9(2)(f)(iv)
- 4. Annex 2 attaches the draft Regulatory Impact Statement (RIS) to accompany the Cabinet paper for Ministerial consultation. While we are still finalising this RIS, initial advice from the Ministry's RIA panel is that this RIS will not meet the regulatory impact standards. This determination is consistent with what we have previously advised you around the speed of this legislative process meaning that multiple elements of good regulatory stewardship will not be undertaken [METIS 1342496 refers].
- 5. We are currently undertaking departmental consultation on the Cabinet paper separately. This will be completed by 13 March.
- 6. An update on the scope and timeframes for revising the licensing criteria in response to the Ministry for Regulation's ECE regulatory sector review is also provided in this report.



## Update on recommendation 9: revising the licensing criteria

- 19. A key component of recommendation 9 of the Ministry for Regulation's report is to revise 72 of the 98 licensing criteria for centre-based ECE services by merging, amending, and removing criteria, and replacing specific criteria with guidance.
- 20. The Ministry for Regulation's specific proposals provide a clear starting point for this project. We have undertaken scoping and planning work to confirm an approach for revising these licensing criteria.

#### Scope

- 21. This project will primarily focus on changes to the licensing criteria for centre-based services. This reflects the Ministry for Regulation's line-by-line review of the criteria for centre-based services. Corresponding changes will be made for licensed hospital-based services and home-based services where they have substantially similar criteria to centre-based services.
- 22. We consider that changes to licensing criteria for kōhanga reo (which are different to those for other service types) are currently out of scope. Kōhanga reo have a different process for changing their licensing criteria, as identified in the Waitangi Tribunal's report on the Kōhanga Reo Claim (Wai 2336). Te Kōhanga Reo National Trust also did not provide feedback on specific licensing criteria during the Ministry for Regulation's review in the way that other parts of the sector did. This means the starting point is different, as we are not starting with existing Ministry for Regulation recommendations.
- 23. Future changes to licensing criteria for kōhanga reo will become part of the Ministry's work programme. The Ministry will work closely with the Trust to make sure these changes are implemented effectively over a longer timeframe and will update you on these discussions in April 2025.
- 24. There are currently thirteen curriculum-related licensing criteria. The Ministry for Regulation recommended retaining two and moving eleven to guidance.
- 25. The curriculum-related recommendations come under Minister Stanford's portfolio responsibilities. As such, we will provide your office with a draft letter to Minister Stanford on 11 March seeking her confirmation of the approach for responding to the curriculum-related recommendations. This approach will broadly set out:
  - 25.1. The Regulations that set curriculum standards will remain unchanged, and these will continue to be the standard that support the broader curriculum reforms underway.
  - 25.2. Reducing these licensing criteria will remove duplication in the system and is intended to support a better functioning regulatory system.

#### Risks

27. We are undertaking options analysis and impact analysis at pace. The timing and pace of this work limits quality assurance and means that elements of good regulatory stewardship and consultation will not be undertaken. These issues combined increase the policy failure and litigation risks associated with this work.
