Please note:

In order to make a decision on whether to proceed with reprioritising funding for RT Literacy and RT Māori, the Minister required an early Budget decision from Cabinet before she could initiate the reprioritisation proposal.

The Minister was then required to give notice of her intention by 1 March and seek feedback on the proposal, which is the process the Minister followed.

Final decisions on the proposal were made after the Minister had received and considered the consultation feedback.

### Why are we sending this to you?

 You are receiving this because you need to seek early Budget decisions for three more initiatives, in addition to the two we have already advised you about (Principal bargaining and assessment tool).

### What action do we need, by when?

- We recommend that you send attached draft letter to the Minister of Finance (Annex 1) by 22 January 2025
- Please return this signed paper by 21 January.

# **Alignment with Government priorities**

- 1. This report supports the Government's Budget priorities to:
  - Deliver more efficient, effective and responsive public services to all who need and use them in particular, to improve educational achievement.
  - Get the Government's books back in order and restore discipline to public spending.

## Background

- 2. This paper outlines the processes, decisions and timing for the early Budget decisions that the Ministry recommends you seek.
- 3. Precommitments are early Budget decisions made by Cabinet, when Cabinet's agreement is required *before* Cabinet is expected to make its full Budget 25 decisions in April 2025.
- 4. Those early decisions enable the Ministry to start implementing the relevant initiatives.

#### **B25 - Early Budget decisions**

- 5. Ealy Budget decisions have three major stages, and we annex a graphic with the major milestones (Annex 2).
  - Advise the Minister of Finance (MOF)
  - Cabinet paper process
  - Implementation work commences
- 6. You have already agreed to seek early decisions for Principal Bargaining, so that bargaining can commence in March.
- 7. The Ministry will shortly provide you with advice on the need for early Budget decisions on the assessment tool, in order to get procurement underway so that it will be operational from Feb 2026.
- 8. The Ministry recommends that you also seek early decisions for these three initiatives:
  - Teaching Council fees, because a) the Council will start to consult on fees in March, and b) to integrate with bargaining timelines
  - Resource Teachers, Literacy (RT Lit) savings because under the collective employment contracts, the Ministry needs to give notice by 1 March
  - Resource Teachers, Māori (RT Māori) savings because under the collective contracts, the Ministry needs to give notice by 1 March.

#### Principal bargaining and Teaching Council fees

- 9. We advised you about the need for Teacher and Principal bargaining before Christmas, and you wrote to MOF on 18 December 2024.
- 10. Because the Teaching Council needs to consult on its proposed fees and levies in early March 2025, you need a Budget 2025 pre-commitment so that you can confirm the funding to remove or reduce the fees. This timing is also aligned with principal and teacher collective bargaining which commences in March 2025.
- 11. We are preparing more detailed advice for you on the Teaching Council fees, which you can expect shortly.
- 12. We recommend that fees and bargaining initiatives are dealt with in one Cabinet paper because of the way the Teaching Council funding interacts with the bargaining ecosystem, and the need for a single timeline for these two initiatives.

13. The proposed timelines for these pre-commitment decisions are in this table:

Savings – RT Lits and RT Māori

- 14. To be realised from 2026, the savings you want from RT Lits and RT Maori need early Budget decisions, so that the Ministry can communicate with school boards and make changes to the Staffing Orders.
- 15. In order to notify employing boards by 1 March, Cabinet will need to agree to the savings before the end of February. We propose that these two savings are dealt with in one Cabinet paper.

#### Kāhui Ako

17. Having examined the timeline for Kāhui Ako savings, we have concluded that this does not need a pre-commitment, providing that Cabinet's Budget decisions are completed by early May 2025.

### Risks

- 20. Because the Teaching Council fees proposal is part of the coalition government agreement, we do not expect that Cabinet will refuse to make an early Budget decision.
- 21. If Cabinet does not agree to these early savings proposals, then you will not be able to realise the savings until 2027. That will also affect your ability to deliver your planned Learning Support package.

#### 22. 9(2)(f)(iv)

The Ministry will provide you with a workforce communications plan that takes account of all the moving parts in this area, relating to Budget (2)()

# **Financial Implications**

23. Cabinet papers for early decisions will include Financial Recommendations. Drawdown recommendations will only be included where essential (e.g., Teachers Council fees, so they can make essential IT system changes before 1 July).

### **Next Steps**

24. As a first stage, we annex a letter to the Minister of Finance advising her of your intention to seek early decisions. We recommend that you review and send this letter as soon as possible so that we can proceed with developing the Cabinet paper.
