Roslyn School (#2439)

Draft Enrolment Scheme Description

Proposed to be Effective Term 1 2026

The guidelines for development and operation of enrolment schemes are issued under Schedule 20 of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below, and shown on the attached map, shall be entitled to enrol at the school. Both sides of each road are included in the zone unless otherwise stated

In a clockwise direction:

- 1. The zone begins at the intersection of Railway Road and Roberts Line, and travels southeast on Roberts Line to its intersection with Kelvin Grove Road.
 - Addresses on Railway Road north of Roberts Line are not in-zone.
 - Addresses on Roberts Line west of Railway Road are not in-zone.
- 2. From the intersection of Roberts Line and Kelvin Grove Road, the zone follows Kelvin Grove Road east to its intersection with James Line.
 - Addresses numbered on Kelvin Grove Road east of the intersection with James Line are not in-zone.
 - 185 Kelvin Grove Road is in-zone.
- 3. At the intersection of Kelvin Grove Road and James Line, the zone travels south on James Line to its intersection with Schnell Drive.
 - Addresses on James Line south of the interaction with Schnell Drive are not in-zone.
 - 162 and 168 James Line are in-zone.
 - 150 James Line is not in-zone.
- 4. From the intersection of James Line and Schnell Drive, the zone follows Schnell Drive south to its intersection with Fernlea Avenue.
 - Addresses on Meridian Grove and Sorrento Place are in-zone.
 - All addresses on Schnell Drive are in-zone.
- 5. From the intersection of Schnell Drive and Fernlea Avenue, the zone follows Fernlea Avenue west to its intersection with Roberts Line.
- 6. At the intersection of Fernlea Avenue and Roberts Line, the zone follows Roberts Line south to the rail corridor.
 - Addresses on Liberty Grove are in-zone.
 - Addresses on Roberts Line south of the rail corridor are not in-zone.
- 7. From the intersection of Roberts Line and the rail corridor, the zone travels west along the rail corridor to a point adjacent to the western end of Royal Oak Drive.

- 8. From a point on the Rail Corridor adjacent to the western end of Royal Oak Drive, the zone then travels south following property boundaries to the eastern boundary of 273 Napier Road.
 - Addresses on Royal Oak Drive are not in-zone.
 - 273 Napier Road is in zone.
 - 291 Napier Road is not in zone.
- 9. At the eastern boundary of 273 Napier Road the zone follows Napier Road west to a point opposite the southern end of Vogel Street.
 - Only addresses on the northern side of Napier Road are in-zone.
- 10. From a point on Napier Road opposite the southern end of Vogel Street, the zone travels north on Vogel Street to its intersection with Tremaine Avenue.
 - Addresses on Upper Main Street, Rangiora Avenue and Andrews Avenue are not in-zone.
 - Addresses on Featherston Street between Vogel Street and Belfast Place are in-zone.
 - Addresses numbered on Elliot Street and Coromandel Court are inzone.
 - Addresses numbered on Belfast Place are not in zone.
 - 605 Featherston Street is in zone.
 - 599 Featherston Street is not in zone.
 - Addresses on Tweed Street, and Tyne Street are in-zone.
- 11. At the intersection of Vogel Street and Tremaine Avenue the zone continues north onto Railway Road returning to the starting point at the intersection of Railway Road and Roberts Line North.
 - Addresses on Tremaine Avenue up to and including 787 and 834 Tremaine Avenue are in zone.
 - Addresses on Thames Street, Humber Street, and Esk Street are in zone.
 - Addresses on Malden Street up to and including 26 and 39 Malden Street are in zone
 - El Prado Drive, Alderson Drive, Valor Drive and Newry Drive are in zone.

In-Zone Enrolments

Proof of residence within the home zone may be required.

Each year applications for enrolment in the following year from in-zone students will be sought by a date which will be published by notice in a media suitable for the local community. This will enable the school board to assess the number of places which can be made available to students who live outside the home zone. (This paragraph is optional)

Out of Zone Enrolments

Each year the board will determine the number of places, and the number of pre-enrolment periods, which are likely to be available in the following year for the enrolment of students who live outside the home zone. The school board will publish this information by notice in a media suitable for the school and wider local community. The notice will indicate how applications are to be made, the date by which all applications must be received, and the date any ballot will be held.

Applications for enrolment will be processed in the following order of priority, according to legislation:

First Priority This priority category is not applicable to this school as it does

not operate a special programme approved by the Secretary

of Education.

Second Priority will be given to applicants who are siblings of current students.

Third Priority will be given to applicants who are siblings of former students.

Fourth Priority will be given to any applicant who is a child of a former student

of the school.

Fifth Priority will be given to any applicant who is either a child of an


employee of the board of the school or a child of a member of

the board of the school.

Sixth Priority will be given to all other applicants.

Note: Applicants seeking second, or third priority status, may be required to give proof of a sibling relationship.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under clause 3 schedule 20 of the Education and Training Act 2020.
