Isolation Allowance (IA)

About:

You'll be paid an *Isolation Allowance* if you're an area teacher or principal employed in a school/kura whose work required that they reside at an isolated location as outlined below.

The rates and conditions may differ depending on the collective agreement you are employed under. Please check your employment agreement for full details, conditions, and requirements.

Eligibility:

- **ATCA Clause 3.23.5 (a):** For an employee whose full-time residence is in a locality with a population of less than 300 that is also between **60km and 150kms** (inclusive) from a population centre of more than 1,500 people, the rate of the allowance shall be **\$1,200 p/a**.

- **ATCA Clause 3.23.6:** For an employee whose full-time residence is in a locality with a population of less than 300 that is also **more than 150kms** from a population centre of more than 1,500 people, the rate of the allowance shall be **\$2,200 p/a**.
