## Why are we sending this to you?

- This report provides a draft Cabinet paper: 'Next stage of the Charter School | Kura Hourua model' for Departmental and Ministerial consultation, attached as Annex 1.

## Key facts, issues and questions

- We have incorporated your feedback and updated the Cabinet paper based on Minister Stanford's decisions regarding a proposed pathway back to the State schooling system [METIS 1344777 refers]. She has agreed to progress option 3, in which the Minister of Education must establish a new State school if a converted charter school voluntarily closes unless specific criteria apply.
- We will undertake targeted consultation on the draft Cabinet paper due to the specific nature of the proposed policy decisions and truncated consultation period (provided in the table below). We will consult with: the Treasury, Department of Prime Minister and Cabinet, Te Kawa Mataaho Public Service Commission, Ministry for Regulation, Charter School Agency, Education Review Office, New Zealand Qualifications Authority, and Social Investment Agency.
- Below is an estimated timeline for lodgement, for the paper to be considered at Cabinet Business Committee on 30 June.
