

Riwaka School (3217)

Enrolment Scheme

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below shall be eligible to enrol at the school.

The Home Zone includes addresses on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from the western end of Horizon Way, the home zone follows:

- North-east along Horizon Way until Factory Road
- East along Factory Road until Main Road Riwaka
 - Including Swamp Road to the south of Factory Road up to, and including, 83 Swamp Road
- South-east along Main Road Riwaka until its intersection with Umukuri Road and River Road
- South along River Road until the end of River Road
 - Including Umukuri Road to the west of Main Road Riwaka up to, and including, 38 Umukuri Road
- From the end of River Road jumps south to the Motueka River
- North-east along the northern bank of the Motueka River until the coastline
- North along the coastline until it is on-line with Harvey Road (by Abel Tasman National Park)
- From the coastline jumps north-west to the end of Harvey Road
- South-east along Harvey Road until Sandy Bay-Marahau Road
- South along Sandy Bay-Marahau Road until Riwaka-Sandy Bay Road
 - Including all side streets off Sandy Bay-Marahau Road
- West and then south along Riwaka-Sandy Bay Road until Takaka Hill Highway
 - Including Moss Road
- West along Takaka Hill Highway up to and including 1693 Takaka Hill Highway
 - Including Riwaka Valley Road,
 - Including Riwaka Valley Left Branch Road,
 - Including Canaan Road,
 - And including Bates Road
- From 1693 Takaka Hill Highway travels east back along Takaka Hill Highway until Main Road Riwaka
- South along Main Road Riwaka until Swamp Road
 - Including Dehra Doon Road
- South along Swamp Road until Factory Road.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date that will be published by public notice in a medium appropriate to

the area served by the school. This will enable the board to assess the number of places that can be made available to students who live outside the home zone.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Each year the School Board will determine the number of places which are likely to be available in the following enrolment period(s) for the enrolment of students who live outside the home zone. The Board will publish this information by public notice in a medium appropriate to the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

- **First Priority:** is not applicable at this school because the school does not run a special programme approved by the Secretary for Education
- **Second Priority:** will be given to applicants who are siblings of current students.
- **Third Priority:** will be given to applicants who are siblings of former students.
- **Fourth Priority:** will be given to any applicant who is a child of a former student of the school.
- **Fifth Priority:** will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school
- **Sixth Priority:** will be given to all other applicants.

If there are more applicants in any priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with [instructions by the Secretary](#), under [Schedule 20, Clause 3 \(1\)](#) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants may be required to give proof of In Zone address, or proof to support their application if seeking enrolment under the Out of Zone priorities.
